# **Veterinary Services Grant Program Overview**

# Purpose and Priorities of the VSGP

RFA Page 6

- To develop, implement, and sustain food and fiber animal veterinary services and relieve veterinarian shortage situations in the U.S., including Insular Areas
  - Complements the VMLRP to address designated veterinary shortages
  - FY2024 veterinary shortage areas: [www.nifa.usda.gov/vmlrp-map](http://www.nifa.usda.gov/vmlrp-map)
- Two program areas
  - Rural Practice Enhancement (RPE)
    - For private veterinary clinics providing services in designated veterinary shortage areas
  - Education, Extension and Training (EET)
    - For accredited schools and organizations to support education and extension activities that will enable veterinarians, veterinary students, veterinary technicians and veterinary technician students to gain specialized food animal skills and practices

## RPE Eligibility

- For-profit or non-profit entity in a current VMLRP Shortage Area
  - Veterinary clinic or hospital located in the U.S. or Insular Area
  - Provides mixed/large animal veterinary services in a rural area
- Clinic or hospital that employs a current VMLRP awardee
  - Has a current service agreement at the time of the application
  - Reference to the single shortage area to which they are obligated to serve
- RPE awards are made to clinics, not individuals.
  - Only a clinic (even if solo practitioner) may apply for and be awarded an RPE grant.
- Shortage situations must qualify as rural
  - All VMLRP Type II shortage situations are rural
  - For VMLRP Type I shortage situations, use the USDA Rural Development's Business Program's Rural Community Development Initiative (RCDI) map

## RPE Funds Can be Used to....

RFA Page 11

- Equip a veterinary clinic
  - Equipment to provide veterinary care for agricultural animals
  - Examples: vehicle, restraints, diagnostic and therapeutic tools
- Reasonable costs for operating eligible veterinary practice
  - Overhead: salary and benefits, DVMs and support personnel, rent, fuel, utilities, maintenance contracts, supplies, software, consultants
  - Overhead costs cannot exceed 50% of the total budget
- Establish mobile or support haul-in veterinary facilities
- Support exposure of students in grades 11 and 12 to opportunities in food and fiber animal medicine and herd health management



## EET Eligibility

- State, regional, or national organization supporting food animal veterinary programs.
- Allied or professional food animal veterinary organization recognized by the American Veterinary Medical Association
- College or school of veterinary medicine accredited by the American Veterinary Medical Association
- University research foundation or veterinary medical foundations
- Department of veterinary science or department of comparative medicine accredited by the U.S. Department of Education
- State agricultural experiment station or Research Farm (1890 institutions)
- State, local, or tribal government agency

# EET Emphasis on Educational Content

RFA Page 10

- Veterinary practice enhancement techniques and strategies that benefit the health of agricultural animals
- Best practices for delivering quality food and agricultural animal veterinary services in rural areas
- Veterinary approaches to foster food safety, epidemiology, or veterinary public health
- Practice management and business planning and development skills
- Career opportunities in food animal medicine.

# EET Funds Can be Used to...

RFA Page 9

- Allow veterinary students, veterinary interns, externs, residents, and veterinary technician students to cover expenses of attending training programs in food safety, public health, or food animal medicine.
- Modify a course(s) of accredited veterinary education programs, including updating course materials for in-person or remote learning; and faculty recruitment and retention for such a course.
- Support training of veterinary residents, interns and externships carried out in coordination with accredited colleges of veterinary medicine.
- Provide continuing education and extension, including virtual and other formats for distance-based education, for veterinarians, veterinary technicians, and other health professionals needed to strengthen veterinary programs and enhance food safety.
- Expose students in grades 11 and 12 to education and career opportunities in food animal medicine.

# RPE or EET Funds Cannot be Used to...

RFA

- Construct or renovate practices or facilities
  - Acquire, expand, remodel or alter an existing facility
- Conduct research
  - Funding for research in agricultural animal health is available through the Agriculture and Food Research Initiative:  
[www.nifa.usda.gov/grants/programs/agriculture-food-research-initiative-afri](http://www.nifa.usda.gov/grants/programs/agriculture-food-research-initiative-afri)
- Establish new (not AVMA-Accredited) Veterinary Medicine or Veterinary Technician programs or curriculums



# Application Submission & Award Limitations

- Eligible clinics may not submit more than 1 application to this program
- Eligible Institutions may submit more than one *application*, but they must be from separate Departments
  - Institutional applicants should work with Office of Research/Sponsored Programs regarding their institution's process to select proposals for submission.
- Limit of 1 *award* per institution per fiscal year.



# Cost Share or Matching

RFA Page 14

- No matching is required.
- Matching resources will not be factored into the review process as evaluation criteria.

  - Figures and tables: Up to 2 additional pages, 1-inch margins
    - Tables may be single spaced, 11-point font
- Within 7-page Narrative describe:
  - Problem Identification / Introduction / Background
  - Objectives / Approach
  - Anticipated Results
  - Timeline
- **Page limits, margins, spacing and font size are strictly enforced**
  - Applications exceeding the page limit will be returned without review

# EET Key Document Specifications

RFA Page 16-17

- See RFA Table 6 on page 16 for Key Instructions
  - Attachments must be in pdf format
- Project Narrative
  - Written text: Up to 12 pages, 1.5 spaced, 1-inch margins, 12-point font
  - Figures and tables: Up to 3 additional pages, 1-inch margins
    - Tables may be single spaced, 11-point font
- Within 12-page Narrative describe:
  - Problem Identification and Significance / Background
  - Objectives / Methods
  - Evaluation Plan
  - Management and Collaboration Plan
  - Timeline
- **Page limits, margins, spacing and font size are strictly enforced**
  - Applications exceeding the page limit will be returned without review

# EET and RPE: Data Management Plan

RFA Page 23

- Investigators must provide detailed (up to 2 pages) business and management plans including:
  - Expected data type
  - Data format
  - Data storage and preservation
  - Data sharing, protection and public access
  - Roles and responsibilities

- Application documents **must be in Portable Document Format (PDF)** to be accepted by NIFA, including your narrative and budget justifications.

# Proposal Evaluation Process

# Evaluation Process

RFA Page 26

Proposals are assigned for review to at least 3 reviewers with expertise in the proposed topic.

Reviewers will produce individual reviews of each proposal, evaluating the strengths and weaknesses.

These written reviews are used to begin panel discussions with other reviewers serving on the peer-review panel.

Through these discussions, peer-review panelists come to consensus on the final rating and ranking of proposals.

# RPE Evaluation Criteria

RFA Page 26

- Expertise and Experience (30%)
  - Demonstration of knowledge, skills, abilities and experience of key personnel
  - Related to shortage area and needs and resources
- Technical Merit (70%)
  - Clarity of objectives, activities and outcomes
  - Clarity of practice operations
  - Value of equipment, overhead, facilities to mitigate the shortage
  - Content and delivery of approach
  - Adequacy of activities to meet needs
  - Likelihood to achieve outcomes
  - Reasonableness of budget

# EET Evaluation Criteria

RFA Page 28

- **Technical Merit (50%)**
  - Clarity of objectives, activities and outcomes
  - Conceptual adequacy to meet needs of target audience and mitigate shortages
  - Expected outputs and outcomes
  - Adequacy of evaluation plan and communication of results
  - Sustainability of project beyond life of the grant
  - Compliance with targets
  - Reasonableness of budget
- **Achievability (20%)**
  - Probability of success
- **Expertise, Experience and Institutional Resources (10%)**
  - Includes consultants, collaborators, facilities equipment

# Timeline of Competitive Programs

**2 months**

- Request for Applications (RFA) release
- Proposal writing and planning
- **Proposals due**

**2-3 months**

- Proposal under peer review
- Proposal funding notifications

**1-2 months**

- Awards are finalized and made

**On average, a competitive program takes about 6 months from the proposal due date to an award being finalized.**
